

# Guidelines for National Taipei University of Education International Students Scholarship

## **I. Regulation**

National Taipei University of Education (hereinafter referred to as the “University”) “International Students Scholarship” aims to recruit outstanding students of foreign nationality to study at the University and promote academic internationalization by way of encouraging and rewarding the University's international students who excel academically.

## **II. Eligibility**

International degree students who meet the article 2 of “International Students Undertaking Studies in Taiwan”(an individual of foreign nationality, who has never held nationality status from the Republic of China and who does not possess an overseas Chinese student status at the time of their application).

## **III. Funds**

The sources of the funds include the budget of the Division of International Affairs and subsidies granted by the Ministry of Education.

## **IV. Qualified applicants**

1. A newly admitted and outstanding student who has not received any other scholarships (including any other scholarships from the Taiwan government).
2. Outstanding international students in NTUE.

## **V. Application Schedule and Materials**

Please apply to the Division of International Affairs according to this guideline.

1. New student: Application form.
2. Current student: Application form, Transcripts, Certificate of Registration.

## **VI. Number of the Awardees**

The number of recipients for each year is subject to the availability of scholarship funds for the year.

## **VII. Amount and Award Period of the Scholarship**

1. Undergraduate students:
  - a. Amount of scholarships: NTD \$4,000 to 6,000 per month/per person.
  - b. Award Period: September to December (New student)  
January to December (Current student)
2. Graduate students:
  - a. Amount of scholarships: NTD\$ 6,000 to 8,000 per month/per person.
  - b. Award Period: September to December (New student)  
January to December (Current student)
3. The number of recipients for each year is subject to the amount of funds allocated to NTUE by the Ministry of Education.
4. The maximum length of time a student is entitled to receive the scholarship is four academic years for undergraduate students, two academic years for students in master programs, and four academic years for students in doctoral programs.
5. Awardees shall provide administrative assistance to the respective department or administrative office for at least 72 hours per year.
6. The scholarship should be terminated immediately after awardees' suspension, withdrawal or graduation from studies; the scholarship received should be reclaimed.

**VIII.** The University sets up the "International Scholarships Review Committee" where the Vice President shall serve as the convener, the Dean of the Office of Research and Development, the Dean of the Office of Academic Affairs, the Dean of the Office of Student Affairs, the Deans of various Colleges, the Director of the Accounting Office and the Chairpersons of the applicants shall serve as *ex officio* committee members, and the Director of the Division of International Affairs shall serve as the *ex officio* committee member as well as executive secretary. The International Scholarships Review Committee shall take charge of reviewing the applications for the "International Students Scholarship."

**IX.** This regulation shall be put into enforcement after being resolved in the University's Administrative Meeting and approved by the University's President.
